- (Rule (13))

**Returns of Purchases By A Buyer**

The Buyer shall, before the fifteenth day of every month submit to the Board a Return in form 7 of all tobacco purchased by him in the previous month.

**Other Tobacco (Marketing and Licence) Rules**

The Buyer shall strictly observe and comply with other relevant Tobacco (Marketing and Licence) Rules, failing which the Board may cancel or suspend the licence under Section 48 of the Tobacco Act.

- (Section 68 of the Tobacco Act)

**Deduction from Purchases of Tobacco**

The Buyer shall pay the purchase price of the tobacco bought to the holder of the Sales Floor Licence on whose floor tobacco is sold

The holder of a Sales Floor licence is the only person authorized to deduct charges from Tobacco Purchases and pay the balance to the seller or his Agent, NOT the Buyer, except for loans or advances given by the Buyer to the Seller, which the Buyer may deduct.

- NOTE: 3 - This return is to be submitted to the Secretary, Tobacco Board of Zambia, P. O. BOX 31963, Lusaka not later than the fifteen of the month following that to which it refers.
